# CAA SOUTH CENTRAL ONTARIO CAA Give & Get Contest – CONTEST RULES

#### **ELIGIBILITY**

1. The CAA Give & Get Contest ("Contest") sponsored by CAA Club Group (operating as CAA South Central Ontario) ("CAA") is open to CAA Members who reside with in the club territory of CAA South Central Ontario as of June 10, 2019, and have reached the age of majority in the Province of Ontario (18 years of age) as of the date of entry for the Contest with the following exceptions: current CAA Auto and/or CAA Home insurance policyholders, employees and retirees of CAA and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest. For the purpose of these Contest Rules, "Immediate Family" means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

#### **HOW TO ENTER**

- 2. No purchase necessary. The two (2) ways to enter this contest are as follows:
  - a. Online Entry method: Eligible Members can enter the contest by visiting the contest website <a href="CAAGiveandGetcontest.com">CAAGiveandGetcontest.com</a>, entering a valid Membership number, completing the required information and clicking submit to enter.
  - b. - 4. Only one (1) entry per valid membership number.
